## Privacy Policy Statement

Hong Kong Dental Association (“HKDA”) respects personal data privacy and is committed to fully implementing and complying with the data protection principles and all relevant provisions under the Personal Data (Privacy) Ordinance (Cap. 486) (the “Ordinance”). When we collect personal data from individuals, we will provide the with a Personal Information Collection Statement (“PICS”) on or before the collection in an appropriate format and manner (e.g. in the same paper form or web page that collects the personal data). ### STATEMENT OF PRACTICE

#### Kinds of Personal Data Held

The personal data held by HKDA mainly includes the name, nationality, correspondence address, telephone number, email address, membership number, if applicable, of the registrants of the HKIDEAS 2024.

#### Main Purposes of Keeping Personal Data
